Additionally, as Dean, I continue to supervise our academic success faculty and initiated mandatory one-on-one academic advising, regularly scheduled skills training sessions and workshops, and an efficient method for faculty to refer students that need supplementary academic support. Beyond the required bar prep skills courses, I created a supplementary bar prep program that enhances the commercial bar prep offerings. STU LAW provides a Dean's Bar Study Kickoff with each group of graduates, as well as a Bar Study Boot Camp with our Florida Bar experts. Throughout the bar prep period our program provides additional lectures as well as practice essay writing opportunities with individual feedback.
